With the state's gaping budget deficit and national economic meltdown dominating headlines and legislative agendas, California's workers had another year of bad news from Sacramento. Key legislation, including a bill that would have given all California workers the right to paid sick days, was stalled because of the state's dire fiscal condition.

Unfortunately, many more bills were stopped by the influence of powerful corporate interests. Despite home foreclosure rates not seen since the Great Depression, Governor Schwarzenegger vetoed legislation that would have regulated the financial industry and kept Californians in their homes. He shot down a bill to ban a toxic chemical from food wrappers and one to curb the misclassification of workers as independent contractors. Schwarzenegger even rejected a bill with bipartisan support that would have decreased fraud in the workers' compensation system. All told, nearly a dozen Federation-supported bills made it to the Governor's desk and died there.

One key bill, unfortunately, did not. At the end of the regular session, as the legislature set an all-time record for late approval of a budget, working families and their economic security were sold out. The legislature passed, and Governor Schwarzenegger signed, a bill to take away the right to overtime pay for some workers in the high-tech industry.

This wasn't just a wage takeaway from working families in the middle of a recession – it was the first time that the budget process has been used to set policy unrelated to the budget and undermine the rights of a group of Californians. Now that this disastrous precedent has been set, groups like the Chamber of Commerce are hoping it won't be the last. This unconscionable takeaway and the flurry of other anti-worker proposals it has already unleashed have set the stage for a defense-based 2009.

This bill, AB10, pushed many legislators out of their 100% voting record.

Despite these setbacks, we look forward to better prospects for working families in the coming year as we push for accountability in Sacramento and turn to new opportunities in Washington, D.C. for inspiration.

Key Labor Bills

High Tech Worker Takeaway

1. HIGH TECH WORKER OVERTIME TAKEAWAY. AB 10 (BUDGET)

This bill expands the overtime exemption to take away overtime pay from certain workers in the high-tech industry. The bill allows employers to work employees longer hours for less compensation. It represents a significant takeaway for private sector workers that should never have been part of a budget deal.

Assembly Bills

2. HOSPITAL STAFFING FOR NON-NURSE PERSONNEL. AB 13 (BROWNLEY)

This bill would have required hospitals to have a staffing plan for all non-nursing professional and technical classifications.

SUPPORT / VETOED BY THE GOVERNOR
ASSEMBLY: 43-32 on 8/30/08
SENATE: 21-17 on 8/29/08

3. WORKERS' COMPENSATION COVERAGE DATABASE. AB 507 (DE LA TORRE)

This bill would have created a publicly searchable database of employers and their workers' compensation insurance company to discourage workers' compensation fraud and crack down on the underground economy.

SUPPORT / VETOED BY THE GOVERNOR
ASSEMBLY: 77-0 on 8/18/08
SENATE: 28-7 on 8/14/08

4. PUBLIC EMPLOYEE MEAL AND REST PERIODS. AB 628 (PRICE)

A guaranteed lunch break has been a fundamental right since 1947 and there is no reason for any workers to be exempted. AB 628 would have extended meal break protections to publicly employed lifeguards.

SUPPORT / VETOED BY THE GOVERNOR
ASSEMBLY: 46-29 on 1/29/08
SENATE: 23-15 on 7/2/08

5. PUBLIC EMPLOYEE MEAL AND REST PERIODS. AB 1666 (PRICE)

A guaranteed lunch break has been a fundamental right since 1947 and there is no reason for any workers to be exempted. AB 1666 would have extended meal break protections to publicly employed stagehands.

SUPPORT / VETOED BY THE GOVERNOR
ASSEMBLY: 46-29 on 1/29/08
SENATE: 24-14 on 7/2/08

6. FORECLOSURE RELIEF. AB 1830 (LIEU)

Hundreds of thousands of working families are at risk of losing their homes due to predatory mortgage lending practices. This bill would have imposed new standards on the industry to protect working families from being steered into loans they do not understand and cannot afford.

ASSEMBLY: 47-28 on 5/29/08
SENATE: 21-16 on 8/27/08

7. WORKPLACE SAFETY. AB 1988 (SWANSON)

Under current law, employers who are cited for health or safety violations can appeal to the Cal/OSHA Appeals Board before getting rid of the hazard. With delays of up to 24 months before the appeal is decided, workers are left in danger. This bill would have required employers to abate violations while their appeals are being decided.

8. PENDING LAYOFF WARNING EXPANSION. AB 1989 (SWANSON)

During this time of increased layoffs, plant closures, and job insecurity, working families need information about pending layoffs as soon as possible. This bill would have amended the California WARN Act by requiring increased notice of pending layoffs and strengthening enforcement of existing law.

Key Labor Bills

9. IMMIGRANT WORKER PROTECTION. AB 2076 (FUENTES)

This bill would have prohibited state and local governments from requiring employers to use the E-Verify immigration documentation system.

SUPPORT

ASSEMBLY: 43-31 on 5/29/08

SENATE: Held on the Senate floor

10. PAID SICK DAYS. AB 2716 (MA)

Over six million California workers, 40% of the state's workforce, have no paid sick days. This bill would have allowed all workers to earn one hour of sick time for every thirty hours worked.

SUPPORT

ASSEMBLY: 45-33 on 5/28/08

SENATE: Held in Senate Appropriations Committee

11. EXPANSION OF WORKERS' COMPENSATION BENEFITS FOR FIREFIGHTERS. AB 2754 (BASS)

This bill ensures that if a firefighter contracts the potentially life-threatening infection known as MRSA, it will be presumed that it was contracted in the course of doing his or her job for the purposes of qualifying for workers' compensation and disability retirement benefits.

SUPPORT / SIGNED BY THE GOVERNOR

ASSEMBLY: 73-0 on 5/28/08

SENATE: 30-9 on 8/13/08

12. UNDERGROUND ECONOMY. AB 2879 (LENO)

This bill would have required the Labor Agency to notify the Franchise Tax Board of certain labor law or tax violations to better crack down on the worst offenders in the underground economy.

SUPPORT

ASSEMBLY: 47-31 on 5/27/08

SENATE: Held in Senate Appropriations

13. HEALTHCARE COST AND QUALITY TRANSPARENCY. AB 2967 (LIEBER)

This bill would have created a state health care cost and quality transparency plan to improve health care quality, improve data collection, and control costs.

ASSEMBLY: 41-32 on 5/27/08

SENATE: Held in Senate Appropriations

14. EXTENSION OF UNEMPLOYMENT INSURANCE BENEFITS. AJR 56 (SWANSON)

This resolution called on Congress to extend Federal Unemployment Insurance Benefits in the face of a deepening economic crisis and record numbers of Californians out of work.

SUPPORT / PASSED

ASSEMBLY: 45-29 on 5/8/08

SENATE: 22-14 on 6/30/08

Senate Bills

15. PUBLIC HEALTH INSURANCE OPTION. SB 973 (SIMITIAN)

Health insurance premiums have increased at more than twice the rate of inflation each year since 1999. SB 973 would have been an important cost saving tool for health care purchasers across California by creating a public insurance option.

ASSEMBLY: 46-27 on 8/14/08

SENATE: 22-13 on 8/21/08

16. BAN OF TOXIC CHEMICALS IN FOOD CONTAINERS. SB 1313 (CORBETT)

Consumers in California are exposed to deadly toxins from food wrappers containing the toxic chemical PFOA and the workers who make those chemicals are developing cancer. This bill would have protected workers and the public by limiting the manufacture, sale, or distribution of food wrappers containing PFOA.

ASSEMBLY: 43-30 on 8/27/08

SENATE: 21-15 on 8/31/08

17. WORKERS' RIGHT TO SEE THEIR OWN DOCTOR. SB 1338 (MIGDEN)

Our right to see our own doctors if we get injured on the job will expire on December 31, 2009 unless a new law is signed. This bill would have merely deleted that sunset date and continued to allow injured workers to see their own physicians.

ASSEMBLY: 47-30 on 8/12/08

SENATE: 25-15 on 5/27/08

Key Labor Bills

18. TRANSIT WORKER SAFETY. SB 1561 (STEINBERG)

This bill protects transit drivers and the public by excluding those riders who pose a serious safety threat.

SUPPORT / SIGNED BY THE GOVERNOR

ASSEMBLY: 77-0 on 8/18/08

SENATE: 26-10 on 8/28/08

19. JOINT LIABILITY FOR EMPLOYEE MISCLASSIFICATION. SB 1583 (CORBETT)

A cottage industry of consultants has been created to advise employers about how to skirt the law and convert employees into independent contractors. SB 1583 would have held these consultants jointly liable for teaching employers how to misclassify employees.

ASSEMBLY: 44-30 on 8/14/08

SENATE: 23-16 on 5/15/08

20. PUBLIC WORKS CERTIFICATION. SB 1698 (ROMERO)

This bill would have increased oversight and accountability of contractors bidding on public works projects by requiring a public works license certification to ensure they understand the state's prevailing wage and public works law.

ASSEMBLY: 46-29 on 8/27/08

SENATE: 23-15 on 5/27/08

21. JUSTICE FOR JANITORS. SCR 102 (KEHOE)

This Senate Resolution recognizes the contributions of the Justice for Janitors Movement and declares June 16, 2008 to be Justice for Janitors Day in California.
